ADVERTISEMENT FOR APPOINTMENT OF VICE-CHANCELLOR OF KHALLIKOTE UNITARY UNIVERSITY (BERHAMPUR, ODISHA)

Applications are invited from eligible candidates below 63 years of age (as on 31st July, 2024, i.e. born after 01.07.1961) for the position of Vice-Chancellor of Khallikote Unitary University, Berhampur, Odisha. The applicant should be a distinguished academician of proven academic and administrative excellence and a well-rounded personality with a minimum of 10 years of experience as Professor in a University system or 10 years of experience in an equivalent position in reputed research and / or academic organization.

The post carries a fixed pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) with Special Allowance of Rs. 11,250/- (Rupees eleven thousand and two hundred fifty) per month and other usual allowances such as Dearness Allowance. Provision of pay protection is applicable for candidates belonging to Central or State Government Public University or Institution. The tenure of the Vice-Chancellor will be four years from the date he/she assumes office or till he/she attains 67 years of age; whichever is earlier.
