#### **Important instructions, terms & conditions:**

- 1. The letter of consent in the letter Head of the Supplier/Vendor etc. should be signed by the Supplier/Vendor etc. or his Authorized representatives (his/her full name & status) on every page of the document submitted by them along with seal of the firm/agency concerned.
- 2. Incomplete and conditional papers will be rejected.
- 3. The interested Firms/ Suppliers/ Vendors are advised to submit the consent letter for participation in the Exhibition in sealed envelope superscribing "QUOTATION FOR THE SUPPLY OF BOOKS FOR CENTRAL LIBRARY" and send the same through Speed Post/ Registered Post as well as through E-mail (registrar@kuu.ac.in).
- 4. The firm shall quote indicating book-wise price per unit as per our requirement including all taxes, by mentioning the discount percentage as per the format given in 'Annexure-A' (list of the General Books) & 'Annexure-B' (list of the Braille Books).
- 5. At any point of the time, if any of the documents furnished by the vendors/ suppliers found to be false, it would be deemed to be a breach of terms of contract making the firm concerned liable for legal action besides termination of contract.
- 6. Consent and offer of discount should be addressed to the Registrar, Khallikote Unitary University, Berhampur, Ganjam, Odisha-760 001.

- 7. The firm shall submit the filled in application form 'Annexure-C', copy of current Income Tax clearance certificate, IT return documents and PAN information with the papers submitted.
- 8. The Quotation completed in all respect should reach the undersigned on or before 17.06.2025 through Speed Post/Regd. Post only and the quotation shall be opened on the next day on 18.06.2025 BY 5.00 P.M. Any tender received late or after due date and time will be rejected.
- 9. Quality of contents of Books shall be given priority as per the advice of the Committee Members/HoDs.
- 10. The publishers/ participants may exhibit latest editions NEP Syllabus Books/ Referral Books other than the Authors specified in the list.
- 11. The book sellers/ agencies/firms interested to participate in the Exhibition shall bear the cost of transportation/incidentals charges by themselves. Further the eligible firm getting the purchase order shall bear the transportation/incidental charges etc. on its own.
- 12. The dates of Exhibition to be organised are fixed on 20<sup>th</sup> & 21<sup>st</sup> June,2025 from 11am to 5pm.
- 13. The venue of the Exhibitions shall be at New SAMS Building which is situated inside the Khallikote Unitary University Campus.
- 14. The publishers/ sellers/vendor etc. shall display their own banner/flex.
- 15. Electricity and space along with desk and benches to exhibit the book shall be arranged by the university.

## **Terms & Conditions for Delivery of Books:**

- 1. Latest edition of books as per order must be delivered.
- The supplied books should be original printed copy of the publisher and purchased legally through concerned publishers or through authorized distributor/dealer. In no case pirated/remaindered copies or printed through any other despicable mechanism should be supplied.
- 3. The delivery period is within a week from the date of supply order issued.
- 4. The delivery date may be extended after obtaining approval from the authority, if the Supplier Vendor request for an extension citing valid reasons.
- All supply of book should be consigned to the Officer in Charge, Central Library of Khallikote Unitary University, Berhampur, Ganjam, Odisha- 760001 in person against duly signed and stamped delivery challan.

#### **Preparation & Submission of Bills:**

#### **Processing of Bills:**

Payment shall be made after proper verification by the OIC concerned against the supplied items.

#### **Return of Defective Books:**

If a supplied book doesn't confirm to specifications as per supply order or torn or missing or the copy is old or is not in good condition, the Supplier shall replace the same with new one immediately.
