

II. SCOPE OF WORK

A. Introduction:

Khallikote Unitary University invites bids from eligible bidders for "Rate Contract for Supply & Installation of Open-Air Gym Equipment at Khallikote Unitary University, Berhampur with 2 years warranty/ guarantee" in two bid system Technical Bid and Financial Bid.

B. Eligibility Criteria:

Only those bidders meeting both the following capability criteria will be "Technically Qualified" for the project.

I. Technical Capability

- A. The Firm must be registered under GST Act.
- B. The Firm should have completed at least 03 (Three) similar projects during last 05 (FIVE) financial years.
- C. ISO or equivalent certification of quality of OEM.
- D. Authorization certificate of the firm/ OEM (Original Equipment Manufacturer) Certificate.

II. Financial Capability

Average annual turnover of INR 50 Lakhs for the preceding 3 financial years, as per the audited balance sheet statements duly certified by the Statutory Auditor (Balance Sheet and Profit & Loss Account for the financial year 2022-23, 2023-24 and 2024-25 to be submitted).

C. Preparation and Submission of Tender Document:

- I. Complete Sealed proposals shall be sent to specified address through registered post/ speed post no later than the closing date and time.
- II. The bids shall be submitted in English/Odia and shall be sealed in outer and inner envelopes) and all envelopes shall indicate the bidder's name and address. The outer envelope shall be addressed to The Registrar, Khallikote Unitary University, Berhampur with full address of applicant and super scribed as **"Tender for Rate Contract for Supply & Installation of Open-Air Gym Equipment at Khallikote Unitary University, Berhampur"**.
- III. The 1st inner envelope shall be marked Technical Proposal and addressed in the same manner as the outer envelope and shall be in the prescribed format (**Annexure-I to V**).
- IV. The 2nd envelope shall be marked Financial Bid and addressed in the same manner as the outer envelope, and shall be in the prescribed format (**Annexure-VI**). The Financial offer of those who qualify technical qualifications (those who qualifies in the eligibility criteria) shall be opened by informing to the qualified bidders in the presence of the bidders or their representatives, who wish to be present on the specified date and time.

- V.** Bidders shall furnish the information strictly as per the formats given in **Annexure-I to VII** of these documents, without any ambiguity. Khallikote Unitary University shall not be held responsible if the failure of any bidder to provide the information in the prescribed formats results in lack of clarity in interpretation and consequent disqualification.
- VI.** All proposals/ bids/ offers shall be numbered, signed & sealed in each page by the duly Authorized signatory of the bidder. All the alternation, omissions, additions, or any other amendments made to the proposal shall also be initialed by him.
- VII.** If the envelop is not sealed and marked as instructed above, it assumes that no responsibility for the misplacement or premature opening of the proposal submitted. In this case, the prematurely opened proposals will be rejected and duly returned.
- VIII.** Bidders are required to submit only one set of the proposal. Any firm, which submits more than one proposal for the said project shall be disqualified.
- IX.** The Bids without Bid Security/ EMD & Cost of Tender Document will not be considered and will out rightly be rejected.
- X.** The Bids amount is limited up to 5 lakhs.

D. Bid Security:

The Earnest Money deposit of the unsuccessful bidders shall be returned after 15 days of identification of L-1 bidder followed by the agreement.

The earnest money deposit of all the bidders shall be returned in case of cancellation of Tender after opening of Bids and prior to opening of bids, as the case may be. No interest shall be paid on Earnest Money Deposit.

The Bid Security/ EMD of Successful bidder will be retained as Security deposit with Khallikote Unitary University and it shall be forfeited if the bidders violate any terms and conditions of the tender and consequent contract.

The Security deposit of Successful bidder will be returned after completion of Guarantee/ Warranty period.

E. Terms & Conditions of the Offer:

- i. This document constitutes no form of commitment on the part of Khallikote Unitary University, weather in respect of the bidding process or otherwise. Furthermore, this tender document confers neither the right nor the expectation on any applicant to participate in the bidding process.
- ii. Khallikote Unitary University reserves the right to reject any or all of the applicants including the lowest bidder, if it considers necessary to do so, and or to withdraw from the bidding process or any part of the bidding process or to modify any of the terms at any time without giving any reason. Nothing contained herein shall confer right upon a bidder or any obligation upon Khallikote Unitary University, Berhampur.

F. VALIDITY OF BIDS:

Bids shall remain valid and open for acceptance for a period of 45 days from the last date of submission of Bids.

G. Opening of BIDS:

- i. The technical proposals received shall be opened by the Purchase Committee of Khallikote Unitary University in presence of the bidders or the authorized person, who wish to attend, at scheduled date & time, unless intimated otherwise.
- ii. The University reserves the right to reject any proposal, if:
 - It is not signed, sealed and marked as stipulated in Clause C.
 - The information and documents have not been submitted as requested and in the specified in the tender.
 - There are inconsistency between the proposal and the supporting documents.
 - There are **conditions** proposed with the bid.

H. Evaluation of Proposals:

The evaluation will be done in two stages as explained below:

Stage-I: Technical Evaluation.


Stage-II: All the technically qualified bidders are according to the technical specifications only their bid shall be opened and examined by the Purchase Committee. The selection will be done on the basis of LCBS (Least Cost Based Selection) method.

Khallikote Unitary University reserves the right to reject any bid if it is of the opinion that the bidder lacks the expertise, experience and is not in possession of requisite infrastructure required for the purpose of the project. The discretion of the Authority of Khallikote Unitary University in this respect shall be final and binding all the bidders.

Special Conditions of the Technical & Financial Bid


- A. If the bidder is not a manufacturer, the bidder has to provide authorization certificate of the manufacturer company (OEM), failing which the tender shall be rejected and price bid will not be opened.**
- B. The Bidder has to fill all the prices details in Annexure VI for all the items mentioned in Open Air Gym Equipment from Sr. No. 1 to 11, failing which the bid of the Tenderer shall be rejected outrightly.**

I. Acceptance of the Offer, Issuance of Work Order & Signing of Contract Agreement:



1. The University shall issue the Letter of Acceptance (LOA) to the selected bidder of Rate Contract agreement.
 2. The selected bidder is required to send his unconditional acceptance of LOA within 03 (THREE) days from the date of issuance of LOA from Khallikote Unitary University and sign the contract agreement within 07(SEVEN) days.
- 

3. Khallikote Unitary University shall retain the right to withdraw the LOA in the event of the selected bidder's failure to accept the LOA within the limit specified in the above clause. In this event, Khallikote Unitary University shall forfeit the bid security of the selected bidder.
4. Khallikote Unitary University will issue the work order to the selected bidder as per the exact requirement upon the rate contract agreement.
5. Khallikote Unitary University shall terminate the Contract if it is found that the contactor (Bidder) was black listed / debarred on previous occasion by any of the government Departments/ Institutions / Local Bodies/ Municipalities/ Public sector undertaking, etc. An undertaking to this effect shall be furnished by the firm along with Technical Bid in the enclosed format.
6. Installation-Free (The bidder has to bear the cost)
7. Transportation- Free (-do-)
8. All payment will be made after the proper verification of the works and satisfactory functioning of the installed by the committee.





J. Dispute Resolution:

1. In the event of any dispute arising in respect of the clauses of the agreement it shall be resolved through negotiation. Alternatively, the dispute shall be referred to the next higher authority for his decision and the same shall be binding on all the parties.
 2. All disputes shall be under the jurisdiction of the court at the place where the headquarters of the authority, who has executed the agreement, is located.
